GENERAL POLICY ORDERED BY BOARD OF DIRECTORS GIFT ACCEPTANCE POLICY

Purpose

The purpose of this policy is to ensure that all gifts received by Para Ti Global are consistent with the mission, goals, and values of the organization, and that they are accepted in accordance with all legal and ethical requirements.

Acceptance of Gifts

Para Ti Global will accept gifts that are consistent with its mission and that do not create any conflict of interest or compromise its integrity. The organization will not accept gifts that are illegal, unethical, or that would damage its reputation.

Types of Gifts Accepted

Para Ti Global will accept the following types of gifts:

1. Cash: Para Ti Global will accept cash donations in the form of checks, money orders, or electronic transfers.
2. Securities: Para Ti Global will accept gifts of publicly traded securities, including stocks, bonds, and mutual funds.
3. Real Estate: Para Ti Global will accept gifts of real estate, subject to certain conditions and limitations.

Para Ti Global's Board of Directors has the ultimate authority to accept or reject any gift offered to the organization.

Review of Policy

This Gift Acceptance Policy will be reviewed annually by Para Ti Global's Board of Directors to ensure that it remains current and effective. It does not require an annual vote but annual review.
