GENERAL POLICY ORDERED BY BOARD OF DIRECTORS SCHOLARSHIP MAKING POLICY

Purpose

Para Ti Global is committed to providing educational opportunities for students who lack financial resources to pursue their academic goals. The Scholarship Making Policy aims to establish a fair and transparent process for awarding scholarships to eligible candidates. This policy is targeted to apply toward the Para Ti Global Merit Scholarship that aims to support students dedicated to service and academics.

Eligibility: The scholarship program is open to students who meet the following criteria:

- 1. Have a minimum GPA of 3.0 or equivalent
- 2. Are enrolled or planning to enroll in an accredited educational institution
- 3. Have a strong commitment to community service

Scholarship Selection Committee

A Scholarship Selection Committee (SSC) will be established to review all scholarship applications and make recommendations for scholarship awards. The SSC will be composed of members of Para Ti Global's Board of Directors, staff, and volunteers. The SSC will ensure that the selection process is fair, objective, and consistent with the organization's mission. Members of the SSC who have familial relationships to applicants must refrain from influence when reviewing the relevant applicant's application.

Scholarship Application

All scholarship applicants must complete the scholarship application form, which will include the following information:

- 1. Personal and contact information
- 2. Educational background and achievements
- 3. Community service involvement
- 4. Essay describing their educational goals and how the scholarship will help them achieve those goals.

The President and CEO have the full authority to form the application in any way as long as these requirements are met.



Scholarship awards will be based on the applicant's academic achievements, community service involvement, and essay. The SSC will determine the amount and number of scholarships to be awarded annually, based on the organization's available resources. Scholarship awards may be used to cover tuition fees, books, and other educational expenses.

Disbursement of Funds

The scholarship funds will be disbursed directly to the educational institution where the recipient is enrolled. The funds will be applied to the recipient's tuition and fees first, and any remaining balance will be refunded to the student.

Scholarship Renewal

All current scholarships by PTG are one time payments.

Scholarship Program Evaluation

Para Ti Global will conduct periodic evaluations of its scholarship program to ensure that it is meeting its goals and objectives. The organization will also review the scholarship selection process and make adjustments as needed to ensure fairness and transparency.

Non-Discrimination Policy

Para Ti Global does not discriminate on the basis of race, color, religion, gender, sexual orientation, age, national origin, disability, or any other legally protected status in its scholarship program.

Communication

Para Ti Global will communicate the scholarship program to eligible students through its website, social media channels, and other outreach activities. The organization will also provide information on how to apply, deadlines, and other relevant information.



Conclusion

Marketing and Communications Agreement

A scholarship contract must be formed and signed by the recipient and by a PTG representative. The contract shall include a provision to allow the recipient's image, information, and all other relevant information to be included in marketing materials including but not limited to the PTG website, social media, and private letters.
